DUE IN OUR OFFICE BY MARCH 15, 2024

- A. 2024 Ohio Selected Jug Sale contract(s). If payment of proceeds is to be made to any other entity than that listed on registration certificate, owner must either sign the contract or a statement giving permission for such payment.
- B. \$300 entry fee per yearling

MUST BE COMPLETED BY MAY 1, 2024

- A. All yearlings entered into the sale must be registered with the USTA or Standardbred Canada in order to be considered for the sale. **No yearling will be sold as "Unnamed."**

MUST BE COMPLETED BY MAY 15, 2024

- A. Each yearling must be made eligible to a minimum of 8 paid stakes. The Ohio Sires Stakes Program and the Ohio Breeders Championship at Delaware are included in the total number of stakes even though no payments must be made. **STAKE PAYMENTS MUST BE MADE TO THE VARIOUS ENTITIES NO LATER THAN 5/15/2024!**

DUE JUNE 15, 2024

- A. Completed stake forms for each yearling accepted into the sale, with a minimum of 8 paid stakes, including eligibility to Ohio Sires Stakes program and, if the stallion is made eligible, the Ohio Breeders Championship. **STAKING WILL ONLY BE ACCEPTED ON THE FORM PROVIDED OR CAN BE SUBMITTED DIRECTLY FROM A STAKING SERVICE.**

DUE AUGUST 1, 2024

- A. Original, signed, USTA or Standardbred Canada registration certificate for each entry that has not been registered as "held electronically" at the USTA or Standardbred Canada.
- B. Transfer form or electronic signature for any owner listed on registration certificate who has not signed it.

DUE PRIOR TO THE SALE

- A. Coggins test dated **within 60 days of the sale - NO EARLIER THAN 7/13/24.**
- B. Health certificate dated **within 30 days of the sale - NO EARLIER THAN 8/13/24.**
